**B. CHANGES TO THE COMPOSITION OF THE BOARD AND BOARD COMMITTEES**

The board of directors (the "**Board**") of China Star Food Group Limited (the "**Company**") wishes to announce the following changes with effect from 3 July 2017:-

- (a) The relinquishment of the position of Mr Koh Eng Kheng Victor ("**Mr Koh**") as the Chairman of the AC and he will remain as a member of the Audit Committee ("**AC**") of the Company.
- (b) The appointment of Mr Kuan Cheng Tuck ("**Mr Kuan**") as an Independent Director of the Company. Following his appointment, Mr Kuan will also be appointed as the Chairman of the AC in place of Mr Koh, a member of the Remuneration Committee ("**RC**") and the Nominating Committee ("**NC**") of the Company.

The Board considers Mr Kuan to be independent pursuant to Rule 704(7) of the Listing Manual Section B: Rules of Catalist of the Singapore Exchange Securities Trading Limited (the "**Catalist Rules**").

- (c) The appointment of Ms Chen Zhen ("**Ms Chen**") as an Independent Director of the Company. Following her appointment, Ms Chen will also be appointed as a member of the AC, NC and RC of the Company.

The Board considers Ms Chen to be independent pursuant to Rule 704(7) of the Catalist Rules.

Details of Ms Chen's appointment as required under Rule 704(6) of the Catalist Rules are contained in a separate announcement released today.
